Inaugural session started with the lighting of auspicious lamp of knowledge virtually and the recitation of the pious Saraswati vandana, of the Goddess of wisdom and knowledge. Prof. Ajay Kr. Singh, Secretary General, Organizing Committee & Vice Chancellor, Sri Sri University, Cuttack, Orissa was then invited to deliver the welcome address and theme address. Having congratulated the organizing team for organizing the XXII International Conference, he thanked all the delegates joining from different time zones, and then formally introduced and welcomed the eminent speakers of the inaugural session. He further placed on record special thanks to all the sponsors of the conference. He explained the main idea behind the theme of conference "\$ Five Trillion Economy: The Way Ahead" & the efforts made by government through various scheme launched towards fulfillment of the dream of reaching the aforementioned target. The Secretary General enumerated that how the concept of Atmanirbhar Bharat or the earlier concept of self-reliant India gained importance in times of COVID-19 when the entire humanity was locked down in their homes, and laid down the five phases of Atmanirbhar Bharat namely - Businesses including MSMEs; Poor, including migrants and farmers; Agriculture; New Horizons of Growth; Government Reforms and Enablers. Being an optimistic person he believes that although this is a tough task to achieve but if the right kind of infrastructure is provided by the Government and with the support of all stakeholders this task can be achieved. He stressed on innovation and mentioned that even if only two Indian companies become like Amazon, Tesla or Apple, which are trillion dollar companies, this task can be achieved as there is no dearth of talent in India.

After the insightful views shared by Prof. Maheshwari, **Prof. Elena Horska**, Dean & Faculty of Economics & Management, Slovak University of Agriculture, Nitra, spoke about the impact of the pandemic on world economy and elaborated that we need to make strategies in support of local producers, regional development, quality of life of inhabitants, and also develop strategies to work in collaboration for further economic development. On behalf of her department, Prof. Horska offered her premises for collaboration specially for consumer studies as to understand customers, their needs, perception & the reactions.

Then the coordinator of the session welcomed Prof. Rajendra P. Srivastava, Ex EY Professor of Accounting and Information Systems, School of Business, University of Kansas, Lawrence, Kansas, USA, to share his ideas. He elaborated that it is very important for any country to develop its intellectual wealth as we need to build a technically competent workforce to generate new ideas. As a Higher Education Institution, we need to provide an academic environment where we promote creativity, entrepreneurship, critical thinking, and the course & curriculum at every level, but most importantly he stressed on the need to control behavior of these budding managers and providing them training on ethical values.

After the knowledgeable session of Prof. Srivastava. Dr. Kusum Lata. Acting Principal, Sri Aurobindo College (E). University of Delhi, Delhi, addressed everyone. First she congratulated the organizers of the International Conference for a very relevant and positive topic. She mentioned that India is a country of Karamyogis and has the strong character of resilience, hardness and resolve which will make India to stand up on its feet and move ahead with determination.

IQAC in Assessment and Accreditation of Higher Education Institutions"

Dr. Sima Singh, Professor, Delhi School of Professional Studies and Research started the XXII Annual international conference Panel Discussion titled, "\$ Five Trillion Economy: The Way Ahead", by introducing the panelists and welcoming them in the session. The session was chaired by Prof. K. V. Bhanumurthy, Professor of Economics, Delhi Technological University & Former Head and Dean, Faculty of Commerce and Business Department of Commerce, Delhi School of Economics, University of Delhi, Delhi.

Prof. Sima singh Handed over the session to the session chair. The session Chairperson, Prof K.V. Bhanumurthy initiated the Panel Discussion and requested Dr. Shyam Singh Inda to express his thoughts on the Topic of the Panel Discussion, "NAAC RAF and Role of IQAC in Assessment and Accreditation of Higher Education Institutions"

Dr. Shyam Singh Inda, started his speech by explaining the preliminary idea of the new framework and why a shift was necessary from the old to new framework. He expressed that under the new NAAC framework the result of the Assessment and Accreditation exercise of HEI (Higher Educational Institutions) will be an ICT based score, which is a combination of evaluation of qualitative and quantitative metrics. The NAAC RAF has introduced System Generated Scores (SGS) with combination of online evaluation (about 70%) and peer judgment, by visiting the HEI (about 30%). He also emphasized that the utmost importance is given to the Student Satisfaction Survey. Dr. Shyam Singh Inda also conveyed that the objective of HEI should be continuous quality improvement and it should not be the sole responsibility of the IQAC coordinator but multiple support systems to be provided to the IQAC team. Dr. Shyam Singh Inda focused on the importance of stakeholder feedback (Employer, Parents, Alumni, Students) under the Revised Accreditation Framework.

Dr. Rajesh Khajuria started his session by ACBSP introducing as an Global Accreditation Council for Business Schools & Programs. He addressed some of the most significant challenges being faced no-a-days i.e. transitioning to online education Delivery is Asia. He sensitized everybody that ACBSP follows 7 unified standards. These major standards are – Leadership, Strategic Student & Stakeholder focus, planning, Student Learning Assessment, Faculty Focus, Curriculum, and Institution Performance. He suggested that in order to better the quality of online academic programmes, training the faculty members, employing young and tech savvy people, moving from classroom teaching towards blended or online programs are the way ahead. He also reiterated that standards can be modified to address the quality in extensive distance learning environments.

Prof. K.V. Bhanumurthy thanked both the panel speakers and expressed his thoughts on the subject. He focused on the role of the IQAC coordinator that there should be a rotation of the IQAC coordinator and second in command should be inducted simultaneously as it will help in better succession planning as well. Moreover, he suggested that the head of the institution should be more involved in the whole process of IQAC as they have more knowledge. He also mentioned that online education has been a boon as well in some cases wherein it has given vent to the creativity and innovation of some teachers.

Prof. K.V. Bhanumurthy thanked all the panelists for taking out time and giving their expert opinions on the topic.

She suggested that some awareness campaigns should be arranged to popularize online and blended learning in a state like Assam where the majority of the educational institutions are running in conventional mode and through direct face to face teaching between teachers and students.

It was concluded that this is technology which can provide up-to-date information and knowledge to the learners in an equal way across the nation.

TOPIC: FACTORS AFFECTING SKILL DEVELOPMENT IN INDIAN EDUCATION SYSTEM

Ms. Manya Jain, Assistant Professor, DSPSR

She started her presentation by focusing on how skilled human capital becomes the backbone of the economic prosperity of any country, and how well a country can flourish with skilled youths. She described those educational institutions should not only impart the education but also skills to its students. She also explained a variety of skills that are necessary for an undergraduate student like entrepreneurial skill, memory and cognition, logical and enquiry skills, communication and leadership skills, IT skills and many more.

She concluded that four dimensions of skill development in college students are helpful in their personal as well as professional lives. These skills are Lifelong Learning skill, Career enhancement skill, Interpersonal skills, and assessing and analyzing skill. This paper was based on primary data.

TOPIC: GURUKUL EDUCATION AND ITS IMPACT ON MODERN EDUCATION

Mr. Toyanath Adhikari, PhD Research Scholar, Nepal Sanskrit University, Nepal

The presentation was made through the recorded video due to technical hindrance at the end of paper presenter.

Mr. Toyannath presented the contribution of gurukul education system in building modern education system. He emphasized that gurukul education is the root of all knowledge created by the ancient saints (Munis). The teachers in modern gurukul schools are student friendly. Though, policies of modern education are talking about equity and access to education for all, which is also derived from Vedic philosophy. Even continuous Evaluation of modern education system to find out students' achievement, it is also the part of gurukul education applied long ago. The buzz word of today i.e. 'learning by doing' it has also been practiced during Gurukul system.

TOPIC: CHALLENGES FACED BY TEACHERS IN PROVIDING BUSINESS EDUCATION TO HEARING IMPAIRED (HI) STUDENTS

Ms. Bhavana U. B, Research Scholar, Department of Commerce, Govt: College for Women, Vazhuthacaud

Dr. K. Anil Kumar, Associate Professor, Department of Commerce, Govt: College for Women, Vazhuthacaud Ms. Bhavana highlighted the challenges faced by Hearing and Speech Impaired students in class room. She elaborated how difficult is teaching to a commerce and business students who have hearing impaired. Deaf students cannot adapt to real-life situations very easily as hearing students do. They need more time understand, and teachers are forced to complete their syllabus timely and here challenges come. It is obvious that all the teaching methods and techniques applicable to hearing students will not be effective for deaf students. She emphasized over more visual strategies should be preferred to teach Hearing and Speech Impaired students.

She mentioned that the selection and application of the appropriate method of teaching and learning by both the teachers and students will ensure the acquisition of knowledge of the concerned subject among such students.

TOPIC:REGULATION& HIGHEREDUCATION:THECHANGINGCONTOURS

Ms. Soumini Ghosh, Doctoral Scholar, JNU

She highlighted the changes taking place in policies and regulations in higher education system in India. The implementation of the NEP, 2020 will be the key to transform higher education. The need is for the state to strengthen the regulatory system to be more adept at dealing with the changing landscape of higher education, and adequately understanding $_{\mathrm{the}}$ specific needs and expectations of higher education stakeholders by employing a multipronged approach.

TOPIC: EFFECTIVENESS OF ONLINE EDUCATION IN NEPALESE CONTEXT: A STUDY OF BACHELOR LEVEL STUDENTS

Mr. Janardan Paudel, PhD research Scholar, Tribhuvan University, Kathmandu, Nepal

Mr. Paudel described that due to COVID-19, the face to face classes were transformed into new class rooms i.e. online classes on zoom, Microsoft team, and other similar types of the platforms. These online classes had different kinds of technological obstacles at both the ends students and teachers.

Although, in Nepalese context, online education was mentioned in policy documents, but it was not made compulsory. But after pandemic threat, COVID-19, and the imposed lockdown, all educational institutions were closed. And this is how the online classes were commenced to educate the students. But in reality, very few students have got opportunity to join online classes. To take the maximum outcome some online internet package programmes should be managed for teachers and students.

Topic: Impact of Yoga Intervention on Exam Anxiety, Mindfullness, Attention & Memory in School Going Children

Mr. Divyansh Jain, M.Sc. Student, S-Vyasa Yoga University, Bangalore

Mr. Jain stated how yoga helps in controlling anxiety or stress level in school going students. He said that in current scenario students are worried about the exams which comes out in terms of anxiety, depression and stress. The intervention of yoga, encompassing *asanas*, *pranayama*, *prathyhara*, *dharana* and dhyana, appears to be effective in helping children overcome the stress and anxiety.

He suggested that yoga practices would be helpful to school going children for better performance in academics and attain joyful learning.

TOPIC: ANALYSIS ON NATIONAL EDUCATION POLICY MS. SHREYA SHARMA, STUDENT, DSPSR DR. POOJA SHARMA, ASSOCIATE PROFESSOR, DSPSR

Ms. Shreya explained that National Education Policy 2020 is undoubtedly an innovative approach to transform the higher education in India. It beautifully balances the old policy with updated form. This change was much needed. She explained that this change is worth waiting for 34years. If the implementations are done according to the policy it will definitely bring change in the economic development of the country and will bring drastic change in the GDP.

Mr. Mohit Singh Thagunna, Head of Research and Evaluation, Action Nepal, Gyaneshwor, Kathmandu, Nepal, in his paper "Working Capital Management and Financial Performance: Evidence from Non- Financial Firms Listed in Nepal Stock Exchange Limited." taken panel data analysis of 23 non - financial firms, listed in NEPSE for the period of 2001-2018 with 194 firm-year observation and reveals that receivable conversion period and inventory conversion period are negatively associated with profitability. Finally he concluded that significant negative relationship between cash conversion cycle and profitability.

2. Mr. Ram Pal, Assistant professor, DSPSR co-authorship with Dr. Dharamveer Singh Rajpoot, Associate Professor, DCSE, JIIT, NOIDA in their paper "Initialising of partioning **Clustering Method Using Density Based** discussed about the different Approach." machine techniques of learning like Partitioning clustering methods specially K-Means. K-Means is a very important and popular partitioning method. He also told try to resolve the issue of initialization of centre of K-Means. Finally he concluded that results of proposed method with existing methods are better.

3. Ms. Rupina Popli, Assistant Professor, Sri Sri University, Cuttack and Prof. G.S Popli, Director, DSPSR, in their paper "Importance of Creative & Innovative Ideas for Entrepreneurship Development in Today's scenario" try to estimate the challenges faced by business and its impact of country on global basis. They said that our country is also proud of generating many great entrepreneurs with their visionary entrepreneurial approach from the past several

decades. According to the International experts, India has been projected as upcoming market, about which the global funds and investors are very much reliable, confident and positive about their investment option and number of such investors is increasing day by day. Finally they concluded that our country is placed at \$ 2.8 trillion economy at present and has planned to reach at the level of \$5 trillion mark by the end of 2024 if we will register the growth @ at least 12% in dollar terms per annum to achieve our desired targets, which is though very challenging but achievable, as we have abundant of natural resources at our disposal.

4. Dr. Sugandh Rawal, Assistant Professor, DSPSR, in her paper, "Measuring Employee engagement: a key strategic initiative and factors of measurement affecting employee engagement under factor analysis." tried to study the pulse of an employee and the factors of employee engagement and measuring the level of employee engagement in Insurance Industry. Finally she concluded that three factors team coordination, organizational support and working environment have been found better in public sector insurance companies, whereas the in the private sector insurance companies only procedural justice has been found better, She also mentioned that factors affecting employee engagement are more supportive in the public sector as compared to private sector.

5. Mr. Satish Dhokare, Research Scholar and Dr. Arun Gaikwad, Professor & Head Dept of Comm. And Research Centre, Sanganmner, Ahmednagar, in their paper, "An Empirical Analysis of Implementation of IFRS in India: Prospects and Challenges" discussed that the increase in cross-border investment and the proliferation of financial products posed a challenge for companies as they faced multiple standards. Coordination and coordination with the IFRS can significantly contribute to efforts to build global financial reporting infrastructure. International Financial Reporting Standards (IFRS) are now the global business language, complying with more than 40% of the world's IFRS in recent years. They concluded that only the implementation mechanism will not help the procedure, but an adviser is also required. With all these systems in place, the implementation of IFRS in India will be very fluid and precise. The Indian blue chips have started aligning their accounting standards with International Financial Reporting Standards (IFRS), two years before the time required for the transition.

6. Ms. Madhubanti Das, Research Scholar, Amity University, KOLKATA, in her paper "Women empowerment in the hands of companies' social responsibility initiative" discussed that helping women break the asymmetric shackles of the society, giving her the power to make the strategic life choices that will affect her in empowering women. Her study is based on West Bengal, she said that West Bengal though called a land of societal values, and customs still sees gender inequality, biasness and discrimination towards women especially in rural areas, Finally she concluded that women would be empowered by a company's CSR activities, if such activities incorporates initiatives towards equal pay for equal work, proper income opportunities for women, stringent laws that would guard women. let our country wake up and move forward into the ever widening horizon of thought and action ,where women are no longer the deprived class the weaker section of the society, the section requiring laws for its protection, requiring loud voice to be heard, to fight for equality.

7. Ms. Rupa Paul, Research Scholar and Dr. Abhijit Pandit, Assistant Professor Amity Business School, Kolkata, in their paper, "Computational Simulation Techniques in Inventory Management" discussed that inventory systems will manage better with simulation technique. She also discussed some merits and demerits of simulation technique and apply Monte Carlo simulation technique and told that how this method is used to solve a real life problem. She found the inventory sales for a confectionary bakery shop and simulate and predict the sales for next few days. At the end she compared and plotted a graph so as to see and understand simulation better.

8. Mr. Sunil Sutar, Research Scholar of Law, Shivaji University, in his paper "Constitutional Mandate To "UNIFORM **CIVIL CODE**": Legislative Incompetency and Its Consequences in India" discussed that Uniform Civil Code signifies the country follows unique law for civil subject in their territory. India is one country where people living are of diverse religion as Hindu, Muslim, Christian and Parasi. They follow their own personal law with civil subject matter. This leads to controversial issue to equal justice and fundamental rights. Indian constitution inserted Article 44 "Uniform civil code" in constitution under part IV of Directive principles of state policy. As it is constitution mandate, which cast obligation to legislative to look into subject. Finally he concluded that Draft of specific civil subject should be consolidated of previous laws which would be come under one umbrella so as to fulfil constitutional mandate, and protect human rights.

9. Ms. Jessica Thacker, Research Scholar Debdatta Saha. and Dr. Assistant Professor, Faculty of Economics, in their paper, "The "Missing middle" Problem and Firm Agility: The case of Food Processing in India" investigated the issue of firm fragility through the lens of density of size distribution of firms in an industry. They claimed that small firms business strategy focuses on upstream manufacturing activities, medium sized firms targets marketing processed products that is mostly sourced through industrial sales/sub-contracting/ co-processing from small-sized firms. On the other hand, large firms are fully integrated into the supply chain and have the ability to produce their own manufactured items as well as market it themselves. Finally they concluded that marketing inefficiency is the core driver of inefficiency for firms rather than technical inefficiency, with high variability in marketing efficiency scores and less variability in technical efficiency scores

10. Ms. Soumya Agarwal, Assistant Professor, DSPSR in her paper, "Covid-19 and Its Impact on Sectoral Performance of Indian Stock Market: An Event Study Analysis." discussed that outbreak of COVID-19 has weakened the economy of India and its capital market since early 2020. The overall stock market has declined. However, some sectors become highly vulnerable while others continue to perform well even in the crisis period. Given this new reality, she investigated the initial volatility and the sectoral return. She analysed the data for 4 sectors such as, Pharmaceuticals, IT, FMCG, and Automotive of the Indian stock market and applied 'Event Study' method. At last she suggested that pharmaceutical on the day of event and days showed significant positive ahead but Automotive, FMCG and IT sector shown the volatility.
