3. Participants can be Students/ Faculty/ Research Scholars/ Industry Representatives
4. Problem, Idea, Expected Solution / Outcome should be presented (PPT/ Prototype Based)
5. The Decision of the panel will be final and binding

PAPER SUBMISSION GUIDELINES

1. The author should submit a separate Title page with author details, along with full paper to intconference2025@git.edu after the acceptance notification by the Conference team.
2. The paper should be submitted in Word doc only (no PDF will be accepted).
3. The allowed word limit for the paper is between 5000 to 7000 words (including abstract, keywords, and references).
4. Similarity Index of the paper should be less than 15% (including Self-plagiarism), paper should be free of AI.
5. "Student paper" means all the authors are ONLY students of PG level.
6. All registered presenters and participants will get a certificate.
7. All the shortlisted papers will undergo a Blind Review Process.

MANUSCRIPT FORMAT LANGUAGE

1. English Font: Times New Roman, 12-point size
2. Spacing: 1.5 lines Margins: 1 inch (2.54 cm) on all sides File
3. Format: Microsoft Word (.doc or .docx).
4. No pdf will be accepted.
5. APA referencing for all citations.

PUBLICATION POSSIBILITIES:

1. All conference papers will be published in a conference proceeding with e-ISBN and DOI
2. Selected papers will be published in an edited volume with an ISBN and DOI
3. Selected papers will be recommended for the Journals indexed in Ebsco/ ProQuest/ABDC (Subject to Journal policy)
4. Publication is based on further review and acceptance by the respective journal/discretion of Editor.

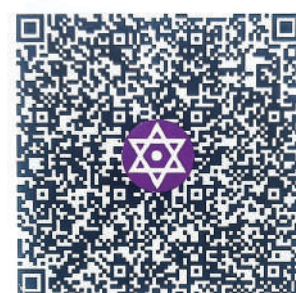
